



## INFORMATION TO THE PROCESSING OF PERSONAL DATA

The personal data of the user are used by MAURIZIO DISTEFANO ADVISORY SOCIETA' UNIPERSONALE SOCIETA' UNIPERSONALE S.r.l., who is the data controller for the treatment, in compliance with the principles of protection of personal data established by the GDPR 2016/679 Regulation.

### **MODALITIES AND PURPOSES OF DATA PROCESSING**

We inform you that the data will be processed with the support of the following means: Mixed - electronic and paper  
The Processing is necessary 1) for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract; 2) for compliance with a legal obligation to which the controller is subject; 3) for the purposes of the legitimate interests pursued by the controller or by a third party, except where such interests are overridden by the interests or fundamental rights and freedoms of the data subject which require protection of personal data ( such as Judicial and extrajudicial resolution of conflicts).

Any refusal to allow the processing of data implies the impossibility of using the service requested by the user.

### **LEGAL BASIS**

The company processes the data of the licensors on the basis of their agreement and in relation to the methods and purposes and treatments described therein.

### **CATEGORIES OF ADDRESSEES**

Without prejudice to communications made in compliance with legal and contractual obligations, all data collected and processed may be communicated exclusively for the purposes specified above to internal authorized persons.

Furthermore, in the management of your data, the same categories of authorized persons and/or external Processors identified in writing and appointed, the list of which can be found at the registered office of MDA, may become aware. You might ask for the complete list of appointees by sending mail to MDA.

### **TECHNOLOGY AND SECURITY PERSONAL DATA**

Your personal data will be processed with IT and management tools in compliance with the principle of necessity and proportionality, avoiding the processing of personal data if the operations can be carried out through the use of anonymous data or through other methods. MDA provides specific security measures to prevent the loss of personal data, illicit or incorrect use and unauthorized access

### **CONSERVATION PERIOD**

The data will be processed for as long as necessary to carry out the existing commercial relationship and for the following ten years from the date of termination of the relationship, according to the statutory prescription terms according to Italian law.

### **RIGHTS OF THE INTERESTED PARTY**

Pursuant to European Regulation 679/2016 (GDPR) and national legislation, the interested party may, in accordance with the procedures and within the limits established by current legislation, exercise the following rights:

• request confirmation of the existence of personal data concerning him / her (right of access); • to know its origin; • receive intelligible communication; • to have information about the logic, the methods and the purposes of the processing; • request the updating, rectification, integration, cancellation, transformation into anonymous form, blocking of data processed in violation of the law, including those no longer necessary for the pursuit of the purposes for which they were collected; • right to limitation or opposition to the processing of data concerning him; • right of revocation; • right to data portability; • in cases of consent-based processing, to receive their data provided to the holder, in a structured and readable form by a data processor and in a format commonly used by an electronic device; • the right to lodge a complaint with the Supervisory Authority.
